Thank you for your interest in applying to participate in our Holiday Treasures. The jury session for Holiday Treasures will be held mid-October. Applicants will be notified of the jury session date.

Applicants should bring 4 - 6 representative examples of the work they would plan to sell, if accepted. Two-dimensional pieces should be presented in a professional manner with quality dry mounting and/or matting and framing. All decisions are based on viewing the actual work.

Major points in Exhibition and Sales Agreement:

- Inventory sheets will be provided to sign in, track sales & sign out
- Items are to be identified as "Assigned Artist Code - Inventory # - XT"
- Artist maintains up-to-date inventory (Back Stock area is limited)
- Gallery insures for loss and damage to work
- SMG retains a 40% commission. Please price your items accordingly
- Artists are paid by the 25th of the month for the previous month's sales
- Gallery collects and remits sales tax
- All work displayed must be of a quality consistent with the juried work
- Items remaining after Christmas Eve are discounted 10%
- Plan to sign out your inventory ASAP after Christmas Eve
- Event ends December 31<sup>st</sup>

The gallery is located downtown Evergreen by Beau Jo's Pizza and Java Groove.
